3. With respect to withdrawals from an account at a financial institution, in addition to providing notice as stated above to Republic Services of Alameda County, you may stop payment of a preauthorized electronic fund transfer by notifying your bank or financial institution in accordance with the procedures that it has established. Termination of a preauthorized electronic fund transfer does not affect your obligation to make timely payment to Republic Services of Alameda County in some other acceptable manner.
4. To the extent allowable by law, the liability of Republic Services of Alameda County in connection with Agreement is limited to the amount of any incorrect charge or withdrawal. Republic Services of Alameda County will not be liable for any other damages, whether direct, incidental, special, or consequential, including but not limited to loss of income or profits, whether or not Republic Services of Alameda County had knowledge that such damages might be incurred. Republic Services of Alameda County also will not be liable: (i) for your acts or omissions, including but not limited to improper or insufficient account or other information, (ii) if you fail to provide current information, should any account or other information change, (iii) if you violate any of the terms of the Agreement; and (iv) for loss, damage, or delay caused by events Republic Services of Alameda County cannot control, including, but not limited to, acts of God, weather conditions, acts of public enemies, war, strikes, civil commotions, or acts of public authorities with actual or apparent authority.
